RESOLUTION DECLARING RESULT OF
ELECTION AND ORDER DECLARING
FORMATION OF "CLOVIS MEMORIAL
DISTRICT".

WHEREAS, a special election was called and ordered to be held on Tuesday, the 4th day of June, 1946, pursuant to the provisions of Division 6, Chapter 1, Sections 1170 to 1235 inclusive of the Military and Veterans Code of the State of California entitled "Memorial Districts" within the territory hereinafter described, for the purpose of submitting to the qualified electors therein the proposition of determining whether or not a memorial district be known as the "Clovis Memorial District" should be formed, and for the election of a Board of Directors consisting of five members to serve from the time of their election and qualification until the election and qualification of their successors at the first general district election; and

WHEREAS, it appears that Notice of said election was duly and legally given, that voting precincts were properly established, that election officers were appointed and election supplies furnished, and that in all respects said election was held and conducted and the votes cast thereat received and canvassed, and the returns thereof made and declared in the time, form and manner as required by said statutes, and the general election laws of the state governing such elections; and

WHEREAS, the Board of Supervisors of said County of Fresno met on Tuesday, the 11th day of June, 1946, said date being the Tuesday next succeeding such election, to canvass the votes cast thereat, as required by law, and, as a result of which, the said Board finds that the number of votes cast, the names of the persons voted for, and other matters required by law, to be hereinafter stated;

NOW THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

1. That the territory proposed to be formed into the Clovis Memorial District as aforesaid is particularly bounded and described as follows:

Commence on the West line of Section 32, Township 12 S; Range 20^E, M.D.B. & M., at intersection with center line of San Joaquin River, being Fresno-Madera County line; thence South to Southwest corner of Section 32, Township 12 S., Range 20 E.; thence East to Northwest corner of Section 4, Township 13 S., Range 20 E.; thence South one-half mile to West quarter corner of Section 4, Township 13 S., Range 20 E.; thence East one-half mile to center of Section 4, Township 13 S., Range 20 E.; thence South one and one-quarter miles to Southwest corner of North half of Southeast quarter of Section 9, Township 13 S., Range 20 E.; thence East one-half mile to Northwest corner of

TO Southeast corner of North half of Southeast quarter of Section 24, Township 12 S., Range 23 E.; thence North two and three-quarter miles to Northeast corner of Section 12, Township 12 South, Range 23 E.; thence West four miles to Southeast corner of Section 5, Township 12 S., Range 23 E.; thence North two miles to Northeast corner of Section 32, Township 11 S., Range 23 E.; thence West eleven miles to Southeast corner of Section 28, Township 11 S., Range 21 E.; thence North five miles more or less to intersection of East line of Section 4, Township 11 S., Range 21 East with center line of San Joaquin River, being the Fresno-Madera County line; thence Southwesterly down the San Joaquin River, along Fresno-Madera County line, to point of beginning.

Within the territory above described is the incorporated area of the City of Clovis, which area is herein described as follows:

Commence on the center line of Section 4, Township 13 S., Range 21 E.; thence West one mile to center of Section 5, Township 13 S., Range 21 E., M.D.B. & M.; thence South one mile to center of Section 8, Township 13 S., Range 21 E.; thence East one mile to center of Section 9, Township 13 S., Range 21 E.; thence North one mile to center of Section 4, and point of beginning.

The above described territory is the sole incorporated territory within the entire proposed Memorial District.

2. That said special election was held and conducted in said territory on Tuesday, the 4th day of June, 1946, in the time, form and manner as required by law.

3. That election precincts were established and provided for in the holding of said special election.

4. That the whole number of votes cast on the formulation of the said Clovis Memorial District and the territory hereinbefore described was 1520, of which number of votes cast therein 1114 were in favor of formation of said Clovis Memorial District, and 406 were against the formation of said Clovis Memorial District.

5. That the names of the persons voted for the office of director, and the total number of votes which each received in the entire territory were as follows:

RESOLVED FURTHER, that as a result of said special election it appears to said Board that the majority of the votes cast in said territory on the question of the formation of the Clovis Memorial District were in favor of formation of said District, wherefore said Board hereby declares the said territory as above described to be duly formed into a district to be known as " Clovis Memorial District"

RESOLVED FURTHER, that at said special election, John B. Andreis, Ira Arbuckle, Carl S. Merriman, Carl Larson and David E. Peckinpah, having received the five highest number of votes for the office of director of said district, are hereby declared to be duly elected to the offices of director of said district.

RESOLVED FURTHER, that the County Clerk be, and he is hereby directed to cause this resolution and order to be entered in full upon the minutes of said Board, and that a certified copy thereof, together with a complete certified copy of the statement of results and a complete certified copy of the petition for the formation of said district, excepting the signatures, thereon, be recorded in the office of the County Recorder of the County of Fresno, State of California, within the time provided by law.

The foregoing Resolution and Order was duly adopted by the Board of Supervisors of Fresno County, California, this 11th day of June, 1946, by the following vote, to-wit:
